Issue

Can a citation be issued for operating an unregistered off-highway vehicle, or all-terrain vehicle, in the Village of Point Venture when the Village of Point Venture is a Master Planned Community?

Brief Answer

The Village of Point Venture (VOPV) is a Master Planned Community and does not rely on Travis County for street maintenance or services. §551A.055 of the Texas Transportation Code authorizes unregistered off-highway vehicles in certain master planned communities. Therefore law enforcement may issue a citation for the operation of an unregistered off-highway vehicle when it is being operated in violation of §551A.055.

Facts

- 1970s site developer dedicated the roads of VOPV to the public
- 1998 VOPV gatehouse removed after a complaint to commissioner's court establishes the roads in VOPV are public
- There is a sign posted at the entrance of VOPV that states "All Traffic Laws will be strictly enforced" [Appendix A]
- May 15, 2018 VOPV entered into an interlocal agreement with Travis County for street maintenance services effective through September 30, 2018.
- Sept 12, 2018 community voted to be a master planned community [Appendix B]

Law & Analysis

Under *Tex. Trans. Code* §551A.055, *OPERATION AUTHORIZED IN CERTAIN AREAS*, *An operator my operate an unregistered off-highway vehicle*: (1) in a master plan community;(A) that has in place a uniform set of restrictive covenants (B) for which a count or municipality has approved a plat; or (2) on a highway for which the posted speed limit is not more than 35 miles per hour, if the off highway vehicle is operated: (1) in the day time; AND (B) not more than two miles from the location where the off-highway vehicle is usually parked and for transportation to or a from a golf course. Furthermore, §551A.033 places restrictions on operation on beaches. A person operating an off=highway vehicle on a beach must hold and have in the person's possession a driver's license. *Id*.

Additionally, a county or municipality may prohibit the operation of unregistered off highway vehicles under §551A.055 if the governing body of the county or municipality determines that the prohibition is necessary in the interest of public safety. See Code §551A.054.

The Village of Point Venture is a master planned community and has a maximum posted speed limit of 25 miles per hour. There has been no prohibition issued by a county or municipality prohibiting the use of unregistered off-highway vehicles in VOPV.

Conclusion

Because VPOV is a master planned community with a set of restrictive covenants and has a posted speed limit below 35 miles per hour a strong argument could be made that the operation of unregistered off-road vehicles is permitted as long as the operation is within the guide lines of *Tex. Trans. Code* §551A.055.

Statutes:

Sec. 551A.054. PROHIBITION OF OPERATION IN CERTAIN AREAS BY MUNICIPALITY, COUNTY, OR DEPARTMENT. (a) A county or municipality may prohibit the operation of an unregistered off-highway vehicle on a highway under Section 551A.055 if the governing body of the county or municipality determines that the prohibition is necessary in the interest of safety.

(b) The Texas Department of Transportation may prohibit the operation of an unregistered off-highway vehicle on a highway under Section $\underline{551A.055}$ if that department determines that the prohibition is necessary in the interest of safety.

Added by Acts 2019, 86th Leg., R.S., Ch. 1233 (H.B. $\underline{1548}$), Sec. 31, eff. June 14, 2019.

Sec. 551A.055. OPERATION AUTHORIZED IN CERTAIN AREAS. An operator may operate an unregistered off-highway vehicle:

- (1) in a master planned community:
- (A) that has in place a uniform set of restrictive covenants; and
- (B) for which a county or municipality has approved a plat; or
- (2) on a highway for which the posted speed limit is not more than 35 miles per hour, if the off-highway vehicle is operated:
 - (A) during the daytime; and
- (B) not more than two miles from the location where the off-highway vehicle is usually parked and for transportation to or from a golf course.

- 4. Roll Call Village Secretary called roll: Present were Mayor Eric Love, Mayor ProTem Stephen Perschler, Councilmember Dan Olson, Councilmember Shelly Molina, Councilmember Steve Hafner. Absent: Councilmember Don Conyer. A quorum was present.

Resident comment to Council regarding recent gunshots fired behind her home. Mayor Eric Love requested resident wait for Detective Pasak report on this subject.

Resident comment to Council regarding short term rental activity large group event shared between several short term rental properties creating physical movement, noise and parking overflow along this portion of the street. Short term renters were directed to park in overflow parking area by POA complex. Resident request consideration to define within short term rental process the type of venues allowed in residential single family home community.

Resident comment to Council concern that consideration would be given to limit on number of properties that may be used as short term rental (less than 90 days) property. Resident request the registration process be given time to take effect and gather data before making any further restrictions.

Resident comment to Council to express concern of the affect of short term rental properties and large number of persons using the property owner amenities and the feeling of community is changing.

C. Mayor's Report

Mayor Eric Love presented bi-annual Spirit of Point Venture award to Justin Orbin. Justin Orbin provides a tremendous amount for our golfing community

Short term rental owner registration is underway, first mail out October 4. We are receiving inquiries and registration applications.

The Council will call for Special Election to fill Council vacancies in January, with period to file application to run through March 28 and election date of May 7.

Mayor Eric Love outlined the next two Council meetings as he has chosen to not seek re-election for Mayor. November and December Council meetings, Mayor ProTem will coordinate and approve agenda items; beginning October 21 checks written will be signed by Mayor ProTem.

D. Travis County Sheriff's Report

Comprehensive report on traffic throughout the Village of Point Venture was not available. Presentation on the Flock system will be scheduled to discuss terms, equipment needs and installation of the Flock System at the Point Venture entrance.

Detective Pasak commented on active investigations (open reports) and need for community to

make report of criminal/suspicious behavior and keep in contact with detective assigned to case, not to speculate, discuss at open meeting or post on NextDoor. Respect the process. Short term rental property noise is same as resident property noise – report for Travis County Sheriff to respond and warn, call in 2nd report if noise does not diminish and Travis County Sheriff may issue

citation. Detective Pasak asked residents not to confront their noisy neighbors, make a report. State Prosecuting Attorney opinion has been received regarding driving ATV/UTV on public streets, Detective Pasak will forward this opinion to the Village Secretary for council review.
