#### Minutes

#### A. Items Opening Meeting

- 1. Call to order Mayor Eric Love called the meeting to order at 6:30 PM
- 2. Pledge Mayor Eric Love led the Pledge of Allegiance
- 3. Invocation Mayor Eric Love
- 4. Roll Call Mayor Love called Council roll in absence of Village Secretary (arrival at 6:38PM). Present were Mayor Eric Love, Mayor ProTem Stephen Perschler, Councilmember Dan Olson, Councilmember Shelly Molina, Councilmember Steve Hafner. Absent: Councilmember Don Conyer. A quorum was present.

#### **B. Public Comments**

Laurie Engels addressed the Council regarding pressing need to establish Village code regarding short term rentals in Point Venture.

#### C. Mayor's Report

Mayor Love thanked all the many who stepped up and gladly volunteered to help during winter Storm 2021:

Curt Webber, John Lundin, Lee Blum, Bryan Murphy and Rod Durham Ray Martinez, Stacie Godfrey, Chris and Samantha Firmstone, John & Tracy Skrasek Village office staff Tommy Low and Vickie Knight WCID Board Member Manuel Macias

D. Travis County Sheriff's Report - Detective Pasak was not in attendance

**Emergency Services Report** - Chief Norman reported there were between 350-400 calls per day for Travis County emergency assistance over a four-day period during the winter storm. Mayor Love reported there will be a sit down planned soon to review emergency response procedures with all Point Venture entities.

#### E. Items to Consider

1. Approval of minutes January 20, 2021 Regular Council Meeting. Councilmember Steve Hafner made a motion to approve minutes of January 20, 2021 Regular Council meeting. Mayor ProTem Stephen Perschler seconded the motion. No discussion. All present approved. Motion carried.

- 2. Final reading and adoption of ordinance amending Chapter 4, Building Regulations, of the Village's Code of Ordinance, to add Article 4.08, Outdoor/Exterior Lighting. Mayor ProTem Stephen Perschler made a motion to approve final reading and adoption of Ordinance 2021-02-17 Outdoor/Exterior Lighting. Councilmember Shelly Molina seconded the motion. No discussion. All present approved. Ordinance 2021-02-17 adopted.
- 3. Reading and adoption of ordinance amending Chapter 11, Section 11.03.001 (b), of the Village's Code of Ordinance, to lower speed limit on all streets within the Village to 25 MPH. Councilman Dan Olson made a motion adopt Ordinance 2021-02-24 amending speed limit on all streets within the Village to 25 MPH. Councilmember Steve Hafner seconded the motion. No discussion. All present approved. Ordinance 2021-02-24 adopted.
- 4. Review proposals and bids received for LED sign. Proposal presented by Focus Digital Displays and placement options were discussed. Mayor Love will have discussion with WCID and POA for potential cost sharing of community LED sign and report to Council.
- 5. Discuss request to erect 4-way stop at the corner of Whispering Hollow and Deckhouse. This concern was brought to Council by a concerned resident. The intersection at Whispering Hollow and Deckhouse can have very busy times on holidays, weekends and does present a safety issue. Council request speed data sign be moved to this location to provide data for Village to quantify the need, findings of fact to safety issue and need. Data and any resident responses and input will be gathered and reviewed, if available, at March Regular Council Meeting.
- 6. Discussion regarding Village wide noise/nuisance ordinance with STR registration proponent. Council has received comments and had several conversations with individuals, whether STR owner or not. Councilmember Steve Hafner wished to recognize that noise/nuisance and STR registration were two separate code items to discuss. Council desire for additional time to consider and make recommendations, feel having this item for discussion at upcoming special workshop meeting would be beneficial. Council will develop recommendations, present to Village attorney for review and comments in developing Village ordinance(s). Mayor Love asked for review at March Regular Council Meeting.
- 7. Review and discussion of variance request for setback encroachment at 18801 Venture Drive. Councilman Shelly Molina made a motion to approve variance request for back yard 20' set back encroachment. Councilmember Dan Olson seconded the motion. No discussion. All present approved.

#### F. Council Reports

- 1. Treasurer's Report October 2020 to January 2021 financial reports in posted digital packet.
- 2. Building Department Councilmember Shelly Molina gave January building report of six new build permits issued (five were townhouse development), two lot clearing permits and one certificate of occupancy for a major remodel.
- 3. Code Enforcement No pending citations, working with recent warnings issued. Mayor Love and Councilmember Dan Olson make weekly drive arounds with Tommy Low to note any outstanding or new code violations.
- 4. Animal Control 202 dogs have been registered for 2021.
- 5. Village Services there were 86 trips to the Community Collection Center in January.
- 6. Public Works Mayor ProTem Stephen Perschler discussed the plan and expenditure request for drainage easement improvements on Staghorn location that will be presented for review at the February 24, 2021

upcoming special workshop meeting.

- 7. P&Z Commission The P&Z Commission has approved standardized guidelines for required drainage plan/study for MF-1 (townhome) and commercial site plan submittals.
- G. Announcements Discussion of date for special called meeting and ordinance review workshop. Wednesday, March 3, 2021 at 5 PM was determined as called meeting date and time. This special called meeting and workshop will be held (with limited attendance available, mask and social distancing required) at Village Office 411 Lohmans Ford. #### Minutes

#### A. Items Opening Meeting

- 1. Call to order Mayor ProTem Stephen Perschler called the meeting to order at 5:00 PM
- 2. Pledge Mayor ProTem Stephen Perschler led the Pledge of Allegiance
- 3. Invocation No invocation was delivered
- 4. Roll Call Vickie Knight called roll. Present were Mayor ProTem Stephen Perschler, Councilmember Dan Olson, Councilmember Shelly Molina, Councilmember Steve Hafner, Councilmember Don Conyer. Absent: Mayor Eric Love. A quorum was present.

#### B. Items to Consider

1. Review and discussion regarding improvement project to address water releasing from drainage culvert on Staghorn.

Councilmember Dan Olson made a motion to approve improvement project for drainage easement between 18515 and 18517 Staghorn and the cost estimate submitted by MCD Construction. Councilmember Don Conyer seconded the motion. Discussion regarding contractor attention to erosion control and staging of work to keep ROW clear. All present approved. Motion carried.

#### C. Ordinance Review Workshop

Mayor ProTem requested discussion of item 2 at this time, to be followed by item 1 discussion.

2. Discuss recommendations from STR task force and input received from Point Venture residents to determine considerations applicable for Village attorney review for effective future ordinance. Council discussion to address short term rental objectives. Mayor ProTem polled each councilmember for top objectives. Registration of current owner/operator contact information is imperative, with or without a minimal registration fee. Placing limits on number of short term rentals allowed (density percentage of short term rentals in Point Venture); minimum stay requirement; occupancy limit requirement to match Texas occupancy rate law; health and safety code inspection report requirement; emergency/fire exit plan posting requirement; require each short term rental property owner signed affidavit of fire extinguisher on site, Point Venture rules, regulations and emergency numbers posted; designated parking areas (what about occasional overflow) to allow no parking on Point Venture streets were discussed. Council desire to not over reach ordinance recommendations and determine how to enforce recommendations for this

ordinance. Mayor ProTem Stephen Perschler recapped discussion points: registration of short term rentals in Point Venture is desired; consideration of designated parking, safety rules posted, enforcement/fines/penalties; Village Secretary requested to contact third party for short term rental property registration and compliance management to speak with Council at upcoming workshop meeting.

1. Review and discuss Village established ordinances.

Noise and Nuisance ordinance will be discussed and developed separate from a short term rental properties ordinance. Council request open discussion with Detective Pasak, Travis County Sheriff's Office, regarding state law regarding disorderly conduct which includes noise/nuisance and how Travis County Sheriff responds to noise/nuisance complaints. Council discussion regarding dissolution of Sec 7.04.007 Lot Maintenance Program and Limb Chipping Service as Village unable to provide this service and Sec 3.03.014 Animal Control and preferred definition for "unreasonable noise". Mayor ProTem Stephen Perschler recapped discussion: Sections of codification to be reviewed and ready for further discussion of updates for Chapter 7 Health and Sanitation and Chapter 11 Traffic and Vehicles Mayor ProTem Stephen Perschler; Sec 9.02 Lot Clearing and Firewise concerns Councilmember Steve Hafner; Chapter 4 Building Regulations and Planning & Zoning Councilmember Shelly Molina; Chapter 12 Utilities Councilmember Dan Olson. Council to determine workshop date in early April.

**D.** Adjourn Councilmember Shelly Molina made a motion to adjourn the meeting. Councilmember Don Conyer seconded the motion. Mayor ProTem Stephen Perschler adjourned the meeting at 6:49 PM.
